I acknowledge that paddle sports /boating/camping and fishing have inherent risks, hazards, and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION

- 1. Water hazards in boating and wading in the rivers including drowning;
- 2. Hiking in rugged country;
- 3. Injuries from fishing equipment and other participants;
- 4. Encounters with wildlife, animals, and insects;
- Temperature extremes;
- 6. Inclement weather conditions and unavailability of immediate medical attention in the wilderness in case of injury.
- 7. Camping, cooking around fires, camp stoves and heat/fire related injuries
- 8. Infectious diseases

I understand the risks, hazards, and dangers of the activities mentioned above, and have had the opportunity to discuss them with my OLTOA trip Leader/Instructor. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF OLTOA WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.
